Are you thinking about moving?

Please call Village Hall and all utilities to inform them you are moving. In most cases you have paid a water deposit to

the Village which is refundable. By informing us you are moving we can start the refund process for those funds.

If you're not moving and have a new phone number, please touch base with the Village Office to give us the best contact number for you.



On the 1st Thursday of the first full week of each month you can put out a single large item to be picked up that will not fit in the provided garbage bin. Please call the Village Office to be added to the special pickup list. October 10th, November 7th and December 5th will be your last large item pickup dates in 2024.

2025 large item pick up dates will be:

January 9th July 10th August 7th February 6th March 6th September 11th April 10th October 9th May 8th November 6th June 5th December 4th

The last day for yard waste to be picked up will be November 30th, 2024.

Live Christmas tree disposal collection will be Friday, January 17th, 2025.

2025 waste calendars should be available for pick up at the Village Office mid-December, electronic copies will also be available on our website and Facebook page.

A Message from Our Village President (Mayor) HAROLD J. MIRE, JR.

Dear Resident(s):

Wow how quickly time flies by. It just seems like yesterday that I was wishing everyone a Happy Holiday Season. As I write this update and Holiday Message, I hope the past year has been good for you and your families. To those of you who may have lost loved ones, on behalf of the Board and the Employees, you and your families have our deepest sympathies.

I'll be brief with my update on Village Projects. The three Capital projects, Waterloop, 13th Street Culvert Replacement and 17th Street Project have now all been completed. There has been some recent re-seeding along 17th Street and we are hopeful it will be successful. The 1% Sales Tax you approved a couple years ago, along with other funds, are being utilized to pay back the Bonds that were taken out to undertake these projects. These 3 projects combined cost in excess of approximately 2.6 million dollars. These Bonds still have approximately 12 years remaining on them. This was accomplished by you the citizens because no federal or state grants were awarded to the 13th Street and 17th Street projects. It was also accomplished without any increases in Village Property Tax Rates.

Speaking of Village Property Tax Rates, the Village Board will be discussing the new Village Tax Rates at our Board Meeting on November 12, 2024. Once again it appears the Assessor has increased our assessments. To offset this increase as much as possible, I will once again propose a reduction in our Village Tax Rate. Our Village Property Tax Rate is currently .5688 and I will recommend to the Board to reduce that property tax rate to .538492. If the Board accepts my recommendation, this will mean that since 2016, the Village and the Board of Trustees have lowered the Village Property Tax Rate on four separate occasions, without any Village Property Tax Rate increase during that period.

I am happy to announce the Village was awarded a BAAD Grant from the Illinois Department of Natural Resources. This grant should be utilized in the area of natural resources and our Schuler's Shady Project qualified for this. The first phase consists of a \$200,000 grant and it will involve replacing the culverts near the boat launch that drain to the river. There are two other phases that we will apply for over the next three years to complete a refurbishment of the entire Schuler's Shady Grove Recreation and Boat Launch area. Additionally, I am excited to announce that we have added some playground equipment to the Shadow Hill Playground for our toddlers and younger children to enjoy. It's always enjoyable to provide for the children.

It's also a great joy to provide for our Seniors as well. I am happy to announce that our 8th Annual Senior Thanksgiving Luncheon will be held on Wednesday, November 20, 2024 at the Rapids City Community Center from 11:30am-1:30pm. Doors open at 11:00am. Please see the front page of the newsletter for more details on Homebound Meal Delivery.

GREAT NEWS! I just received a text from Santa that he will be escorted through the Village by the Rapids City Port Byron Fire Department on December 7, 2024 from 11:00am-1:00pm. He asked for all the kids to be looking for him when they hear the sirens.
